As a 20 year West San Fernando Valley resident, I support the proposed plan by Supervisor Ridley-Thomas called "Community Empowerment Plan S2" because it changes my existing boundary from District west 5 to another district that is an actual part of my community. The other two proposals do not do this for my area and lump us into the Santa Clarita Valley portion of Los Angeles County and out of the San Fernando Valley districts.

Even though I am a citizen of Los Angeles County, it is clear that my concerns as a Western San Fernando Valley resident would be better understood and represented by a supervisor from my area instead of one that has a vast majority of its people live in the Santa Clarita Valley. Sadly keeping the boundary as it currently is in my area, would leave me and my neighbors at a huge disadvantage to have our concerns met and cared for.

Well I do understand that divisions must be made somewhere, they should be kept more inline to represent location instead of race or other criteria.
