Dear County Supervisors:

Plan S2 and Plan T1 violate the Garza case and violate the policy that the various districts represent adjacent communities with similar interests.

The rationale of the Garza case was a finding that there was an intent to impose fragmentation of the Hispanic vote. We are now faced with the opposite intent. Plan S2 and Plan T1 reflect an intent to illegally fragment the non-Hispanic vote in the current Third District which now has a geographic compactness surrounding the Santa Monica Mountains and common interests related to those Mountains.

Plan S2 and Plan T1 would combine all the communities along the Pacific Ocean. The only community of interest they could possibly reflect would be an unrealistic fear of a tsunami rolling over the entire coastline. These "Tsunami Plans" must be rejected because their true intent is to use race as the predominant factor in determining gerrymandered district boundaries.

I submit that all the stakeholders in Los Angeles County would be better served by having leaders who represent and are accountable to the separate communities that have separate interests and separate problems. If the current Third District appears influential, it is because there are important working relationships among the voters with each other and with their supervisor. The "Tsunami Plans" S2 and T1 are designed to illegally disturb the integrity of the current Third District communities.

I strongly support the preservation of the Third District boundaries essentially as they now exist, and as reflected in Plan A3.
