

RESOLUTION NO. 11-27

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA MIRADA
REQUESTING THE COUNTY BOUNDARY REVIEW COMMITTEE TO KEEP
LA MIRADA IN THE FOURTH SUPERVISORIAL DISTRICT**

THE CITY COUNCIL OF THE CITY OF LA MIRADA DOES RESOLVE AS FOLLOWS:

A. Recitals.


- (i) The Los Angeles County Boundary Review Committee (BRC) is in the process of reviewing the five supervisorial district boundaries.
- (ii) The BRC will consider revising these district boundaries and will recommend its redistricting plans to the Board of Supervisors by the end of July.
- (iii) The Board will conduct a series of public hearings and adopt its Supervisorial Redistricting Plan by October 31, 2011.
- (iv) The City of La Mirada is currently in the Fourth Supervisorial District.
- (v) The Fourth Supervisorial District Supervisor and staff understands La Mirada's community interests and needs, and have been highly responsive to the City. Maintaining this relationship is critical to La Mirada in continuing to provide quality services.
- (vi) The City of La Mirada works closely with the County and neighboring cities on significant economic, transportation, water, and air quality projects distinctive to the Southeast Los Angeles County region.
- (vii) La Mirada has existing partnerships with other cities in the Fourth District including Norwalk, Downey, Commerce, Whittier, and Cerritos. Having similar supervisorial representation with regional partners is helpful in accomplishing shared endeavors.
- (viii) La Mirada's significant regional partnerships and interests with other cities should be considered when drawing the final supervisorial district boundaries.

B. Resolution.

NOW, THEREFORE, BE IT FOUND, DETERMINED AND RESOLVED as follows:

1. The City Council of the City of La Mirada requests the Boundary Review Committee keep the City of La Mirada in the Fourth Supervisorial District.


