- Doreena Wong: An outstanding candidate, with legal experience, redistricting experience and lots of engagement with AANHPI community. Also represents the LGBTQ communities. Ticks off many of the same boxes as Priya Sridharan, but I picked Priya because of age and district. . Perhaps an alternate?
- Margaret Milligan: Campaign finance attorney with public interest center, LA Co grand jury experience, child advocacy
- Maria Williams-Slaughter: A black woman with both scientific and educational experience, but too similar to Carolyn Williams, perhaps an alternate
- Mark Mendoza: MA in Urban economics; project manager for firm working with MWD; managed project for LA Metro all around the city. served on appeals panels requiring objectivity. Also R. Would there be a COI?
- Priya Sridharan: An outstanding candidate, law school dean with experience in redistricting, familiar with local city operations.
   Similar background and experience to Doreena Wong (F, Asian-American, D). I don't think we can take both of them. Priya is in District 5, and is younger, thus my choice of her over Doreena
- Saira Soto: Scientific degree, works for Children's defense fund, community coordinator, and represents LGBTQ

- Apolonio Morales: Community activist. Works for CHIRLA and has experience working with immigrant populations. Has broad community support. He is bilingual (English/Spanish).

- Doreena Wong: She is an attorney with over 30 years of public interest law experience. She focused on civil rights issues, including voting rights and redistricting. She is Chinese and has helped LGBTQ communities.
- Mary Kenney: Retired attorney with 40 years of legal experience. Recent work advising veterans on getting their traffic tickets dismissed and getting their criminal records expunged. She is a Republican.
- Saira Soto: Community activist. She works for the Children's Defense Fund in California. She is bilingual (English/Spanish).
   She is latina, immigrant and LGBTQ.
- Theresa Fuentes: She is an attorney for the City of Pasadena.
  She was the legal counsel to Pasadena's Redistricting Task
  Force. He advises the Pasadena City Clerk on issues related to voting, elections, and redistricting.



### Maps of Current Applicants in Commissioners' Slates of 6


#### U.S. Census Population estimates, July 1, 2019, (V2019)
