Hello,

My name is Barbara Sandoval, i'm a homeowner in the Palm Park neighborhood of Whittier and am writing to ask that Supervisor Knane support an additional Supervisor seat. As Supervisor Knabe is aware, Latinos comprise half of the population in Los Angeles County. Yet, there has been no additional Latino representation on the Board of Supervisors since Gloria Molina was elected more than 20 years ago.

I understand that The Redistricting Advisory Commission was presented with several proposed maps creating a second Latino-majority district, and the representatives appointed by Supervisors Knabe, rejected each of these proposals. This is a severe violation of the Federal Voting Rights Act, and could lead the county into a lawsuit, which will cost tax-payer money.

This is an unnecessary and costly road to head down. Do the responsible thing, exhibit leadership and pursue the proposed maps creating a second Latino-majority district. Embracing diversity is a productive approach that will yield benefits for all of L.A. County.

Los Angeles County Board of Supervisors:

I AM HERE TO SUPPORT THE REDISTRICTING PLAN A-2 for the following reasons:

1. Plan A-2 impacts the lives of 150,000 citizens. Plan S-1 disrupts the lives of almost three (3) million citizens.
2. Learning the unique needs of the various communities takes years for the Supervisor and his/her support staff. Under Plan S-1 this learning curve would be extended due to the change in boundaries of many more communities compared to A-2. Given tight budgets and lack of funds, it is not the right time to have "on the job training".
3. The Supervisor must manage the needs of the individual communities as well as the functions that cross community boundaries: Alameda Corridor, Harbors, Airports, etc. To divide these functions into parts and disperse them over several supervisors would not be efficient use of public funds.
4. The current 4th district, with its multi-cultural population, is well represented by Supervisor Knabe. Under Plan A-2 the Hispanic group maintains a healthy 42% representation. This is in a district that has been increasingly populated by individuals of Asian background. If any group is under-represented it is the Asian population. Supervisor Knabe has done an excellent job in representing and meeting the needs of the various cultures in his district.
