Hello,

I have just reviewed the Boundary Review Committee's report and recommendation at <http://redistricting.lacounty.gov/wp-content/uploads/2011/07/BRC-Final-Board-letter-072511.pdf>

I am pleased to see that the recommended redistricting plan retains Altadena as a complete entity within the Fifth District. This recommended plan makes much more sense for Altadena than did several of the other proposed redistricting plans.

Please read this text, which has been taken directly from the Altadena Town Council website at <http://www.altadenatowncouncil.org/> :

Altadena has remained an unincorporated area within Los Angeles County since founding in 1887, and has a Town Council that is among the **Fifth District's most well developed**. The Council's 16 members are elected as an advisory body that communicates and coordinates residents' needs with public agencies and to the **Supervisor of the Fifth District**, its official representative on the Los Angeles County Board of Supervisors.

As **decision makers** on this redistricting effort, the **Board of Supervisors** should be considering the **practical effects** of all proposed boundary changes on the **affected communities** as a whole, and **not just juggling individual census numbers within a vacuum**.

A Google search using the keywords **"+Altadena +Antonovich"** turned up more than **21,000** hits. This number should serve to **quantify the extent of the relationship** that Supervisor Antonovich of the Fifth District has already established with the Altadena community. **There is significant "intellectual capital" at stake here**. Moving Altadena (or even a portion of Altadena) to a different District will cause a "restart from the beginning" of all the existing knowledge and plans and relationships (including Supervisor Antonovich's all-important Field Offices) that **have taken years to establish and nurture**. Supervisor Antonovich has been **both pro-active and responsive** to Altadena's concerns; **Altadena has made significant progress as a result** (note particularly the recent incorporation of the Hillside Ordinance into the Altadena Community Standards District.)


Please leave Altadena intact, and wholly within the Fifth District, in the final redistricting plan.
