Overview and Discussion of Citizens Redistricting Commission

- In 2016, the California Legislature passed Senate Bill 958 requiring Los Angeles County to assemble the CRC following the Federal census.
- Every 10 years, Los Angeles County's Supervisorial District boundaries adjusted
 - Each district is reasonably equal in population
 - Geographically contiguous
 - Boundaries take into account topography, geography, cohesiveness, contiguity, integrity, compactness of territory, and community of interest of the Supervisorial Districts

Purpose

- Ensure Board of Supervisors is representative of the County's population District lines
- Shape a community's ability to elect the representative of their choice

CRC December Goal

Establish a 14-
member CRC by
December 31, 2020

Steps to Date

- **741** applicants in the initial pool submitted to the Los Angeles County Registrar-Recorder
- **533** qualified based on Senate Bill 958
- **60** most qualified names made public for at least 30 days
- Submitted to the Auditor-Controller after 30-day period
- Auditor-Controller conducted random drawing at the Board of Supervisors' meeting on November 24, 2020
 - 1 from each of the 5 existing supervisorial districts
 - 3 randomly drawn from the remaining 55 applicants




Criteria for Selecting CRC Commissioners

- Meet the minimum qualifications (residency, registered voter, etc.) – confirmed already by the Registrar- Recorder
- Reflect the County’s diversity, including racial, ethnic, geographic, and gender diversity
- Demonstrated they possess the following experience:
 1. Analytical skills relevant to the redistricting process and voting rights
 2. An ability to comprehend and apply the applicable State and Federal legal requirements
 3. Ability to be impartial
 4. An appreciation for the diverse demographics and geography of Los Angeles County

REMINDER to the 8 CRC Commissioners: Cannot apply formulas or specific ratios

The current 8 CRC Commissioners satisfy this criterion: At least one CRC Commissioner shall reside in each of the five existing supervisorial districts of the board.







Los Angeles County Population Based on Gender







Los Angeles County Demographics: Race/Ethnicity





Suggestions for Reviewing the 52 Applications

Review Process Before 2nd CRC Meeting

- Every application is reviewed by at least 2 CRC Commissioners.
 - Equates to approximately 13 applications per CRC Commissioner
 - Can assign clusters of 13 applications for each CRC Commissioner to review before the next meeting
- CRC Commissioners may opt to review more or all of the applications.
- Can provide an online link for CRC Commissioners to enter their application assessments, discussed next

2nd and 3rd December Meetings

At the next meeting on December 21, 2020, 10:00 am:

- Receive public comment
- Discuss assessments
- Shorten the list
- Select final 6 CRC Commissioners or determine need for another CRC meeting prior to December 31, 2020
- If a 3rd CRC meeting:
 - Form 2 ad hoc groups of 4 to interview candidates
 - Make final selection of the 6 remaining CRC Commissioners before December 31

Options for CRC Application Assessments

Options	Features
1. Ranking	<ul style="list-style-type: none"> ▪ Each CRC Commissioner ranks candidates from high to low ▪ Compile rankings prior to next meeting
2. Criterion-Based Evaluation	<ul style="list-style-type: none"> ▪ Use criteria outlined in law ▪ Rating Scale: 1 (Low) to 5 (Exceptional) ▪ Example on next slide
3. Segmentation Approach to Reflect LA County's Diversity	<ul style="list-style-type: none"> ▪ Consider CRC membership diversity (e.g., gender, ethnicity/race, analytical skills, experience) ▪ Divide CRC Commissioners into 2-3 ad hoc groups ▪ Have CRC ad hoc groups focus on subpools of applicants, based on diversity
4. Interviews	<ul style="list-style-type: none"> ▪ Divide the CRC Commissioners into 2 ad hoc groups of 4 to interview top-ranked candidates prior to the CRC meeting when the final selection decisions will be made
5. Combination of Options	<ul style="list-style-type: none"> ▪ To be discussed


