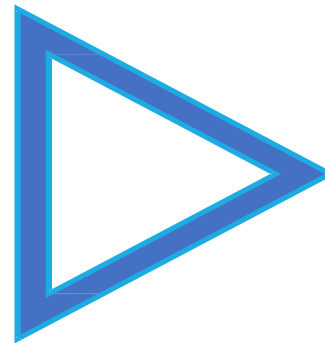

- A nationally recognized scholar of constitutional law and the law of democracy
- Served as a Deputy Assistant Attorney General in the Civil Rights Division of the U.S. Department of Justice, supporting voting rights and protections against employment discrimination (including LGBT rights in the workplace)
- Published in the flagship law reviews at Harvard, Columbia, NYU, Georgetown, and William & Mary, the peer-reviewed Election Law Journal, and the flagship online law journals at Yale and NYU, among others
- Has served as a visiting faculty member at the Yale Law School, at USC's Gould School of Law, and at Caltech
- Received Loyola's Excellence in Teaching Award in 2013-14 and 2019-20
- Maintains the website "All About Redistricting," tracking the process of state and federal redistricting around the country, including litigation: <https://redistricting.lls.edu/>
- Admitted to the bar in California, New Jersey, New York, and the District of Columbia, and to the U.S. Supreme Court, the U.S. Courts of Appeal for the Fourth Circuit, Ninth Circuit, and Eleventh Circuit, and the U.S. District Courts in the Central District of California and Northern District of Florida
- Education: Law degree and a masters degree in public administration from Harvard University

 - Report out from each of the Commissioners about the issues raised at the public forum

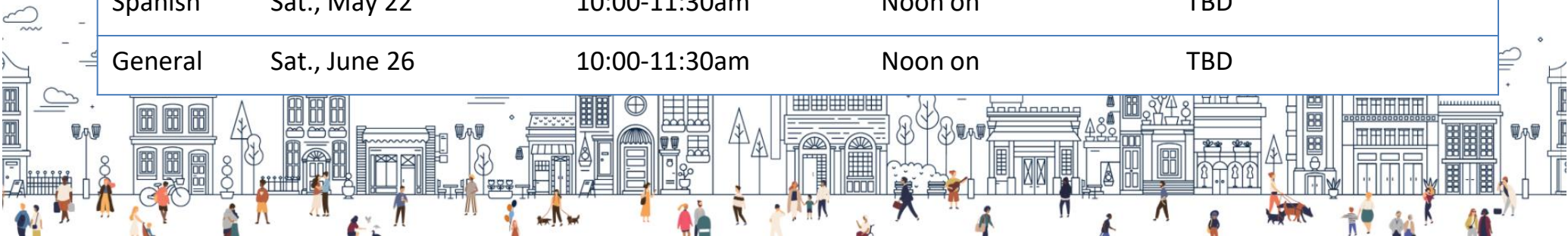

7. Develop a short list of demographers to invite to present before the full LA County CRC	May 12, 2021
