AGENDA ITEM 1: CALL TO ORDER

Thai V. Le, Los Angeles County Citizens Redistricting Commission (LA County CRC) Clerk, called the meeting to order at 7:12 p.m.

AGENDA ITEM 2: ROLL CALL

Governor Newsom signed Executive Order N-29-20, as an emergency measure in response to the COVID-19 pandemic. This Executive Order allows local and state agencies to hold virtual meetings via teleconference and make meetings accessible electronically despite open meeting requirements in the Bagley-Keene and Brown Acts. The Governor signed this Executive Order in March 2020 and extended it through September 30, 2021.

The LA County CRC is launching a hybrid meeting format where Commissioners can attend either in person or virtually and count toward the quorum.

AGENDA ITEM 6: ACTION/DISCUSSION ITEMS – PUBLIC HEARING – PRESENTATION

Co-Chair Carolyn Williams and Commissioners Priscilla Orpinela-Segura and Doreena Wong provided an overview presentation on what redistricting is and how the LA County CRC differs from prior approaches.

AGENDA ITEM 7: PUBLIC HEARING FOR COMMUNITIES OF INTEREST (COI) INPUT

A community of interest is a contiguous population that shares common social and economic interests that should be included within a single district for purposes of its effective and fair representation. Communities of interest shall not include relationships with political parties, incumbents, or political candidates.

The Zone G zip codes include:

Although the focus was on Zone F, members of the public from other zip codes were welcomed and made public comment. Attendees were asked to complete the Community of Interest (COI) Google Forms, in lieu of speaker cards. The written and orally presented testimonies the public provided are summarized as COI input during the public hearing and posted on the LA County CRC for ease of access of the public. Speakers providing public testimony were:

- Henry Fung (SGV, 91722) – San Gabriel Valley (SGV) is currently split into 3 districts: SD1, SD4, SD5. It should be 1 district because of shared issues with air pollution. It's large Asian and Latino populations get along. The eastern boundary should be Claremont and continue west past Whittier and north to the mountains until 2 million residents are achieved. SGV has nothing to do with the Antelope Valley (AV).
- Christian Trigugros displayed his banner, building on his general public comments. He pointed out that the cities, such as El Monte and Whittier, work together with other surrounding cities.
- Diego Rodrigues – Keep Mt. Washington, South Gate, Walnut Park, etc. together. He's with Alma Family Services Master Account.
- Sean Cazares (San Dimas, 91773) – He's with Livable California and United Neighbors. He represents foothills communities that are rural and bedroom communities. San Dimas is similar to Covina, La Verne, and other unincorporated areas and should be compact with SD1.
- Denise Villamil (90042) – Keep NE LA, SGV, Eastside together. Don't fragment them. She's a service provider for youth.
- Yolanda Rodriguez Pena (Azusa, SGV, 91702) – Azusa residents are blue collar workers and Latino. They are not like Claremont or Baldwin Park, who do not understand Azusa's needs.
- Adriana Quinones (Hacienda Heights) – Keep Hacienda Heights and Diamond Bar together in 1 SD. They deal with companies that have contaminated the environment. They want to be with SD 4 (Supervisor Hahn).
- Arturo Jimenez (Pomona, 91767) – Has lived in South Pomona for 45 years, worked at a technical college, and is a school board member. Prefers 1 SD for the SGV. Pomona and Diamond Bar are similar; Claremont is different. South Pomona has a larger Asian population.
- Armando Ng (91754, SD 1) – SGV has many Asians but is divided into 3 SDs. There has never been an Asian Board of Supervisor. There may be a large enough population for an Asian SD.
- Rem Nunez (South Gate) – Keep South Gate, SE LA, NE LA, Highland Park, ELA, Boyle Height, and SGV together. The neediest residents should be in 1 SD because of shared problems (e.g., pandemic). The area extends north to City Terrace and Lincoln Heights and includes La Puente.
- Cesia Romo (SGV) – Keep SGV together (shared needs regarding vaccination and testing sites and other issues)

- Cynthia Gabaldon (Pomona) – Keep Pomona, Citrus, Diamond Bar, and Monrovia together; like one big family
- Loudes Caracoza (ELA, 90022) – Keep ELA with SD 1; shared needs and need continuous support of progress made
- Sandra Flores (La Puente, 90022) – Keep SGV together with NE LA and SE LA. She’s a student at CSU-LA and a child education advocate.
- Nancy Diaz via QA submission – Pomona: “Thank you for clarifying. I have kids running around making it difficult to speak. I am a resident in City of Pomona. My comment is to further assess City of Pomona due to its inequities in representation, economic, and community resources based on sharing between SGV and Diamond Bar. District 5 (Phillips Ranch division) within Pomona has a large decline in population with second highest earners. Schools are closing. Houses are being removed from the freeway 71 expansion. Access to community services is limited. Redrawing of lines in this area has not been done for over 30 years, so consider furhter [sic further] assessing.”

AGENDA ITEM 5: CONSENT ITEMS (RE-ORDERED FROM THE AGENDA – DISCUSSED AFTER THE PUBLIC HEARING PORTION OF THE MEETING)

The Commissioners discussed the July 28, 2021, Draft LA County CRC Minutes of the of the regular meeting and public hearing. The Commissioners made a motion to change the language from:

“A motion was made and seconded to direct ARCBridge to subcontract with Bruce Adelson and Dr. Jonathan Katz to conduct an “Analysis of Racially Polarized Voting (RPV)” in Los Angeles County.”

AGENDA ITEM 8: EXECUTIVE DIRECTOR'S REPORT – GAYLA KRAETSCH HARTSOUGH, PH.D. (RE-ORDERED FROM THE AGENDA – WAS AGENDA ITEM 10.)

Gayla Kraetsch Hartsough reported that Dean Logan, the LA County Registrar-Recorder/County Clerk, has made it possible for us to have a small blurb about redistricting in the Sample Ballot/Voter Information Guide for the September 14, 2021, California Gubernatorial Election. This Guide is sent to every household in LA County and **targets the 5.7 million registered voters**. Here is the blurb:

Gayla Kraetsch Hartsough outlined the roll out of the training plan and redistricting software for this month, including the timeline. Commissioner Holtzman pointed out that some of the cities may need to be divided

between supervisorial districts, based on COI input.

Ground rules

- Other than LA City, keep cities and unincorporated areas together as much as possible
- As much as possible, use RDUs (2,300 Tracts plus cities)

Mapping software training

- Week 1: August: ESRI, ARCBridge, Thai, LA County GIS staff
- Week 2: August 11 and 12: Commissioners
- Week 3-4: August: Public, including LA County training and HELP lines in different languages

Racially Polarized Voting update – Bruce Adelson and Jonathan Katz – targeted for August 22, 2021

2 mapping software phases

- Preliminary maps – submit/review September
- Official maps – submit/review October

CRC Commissioner deadlines

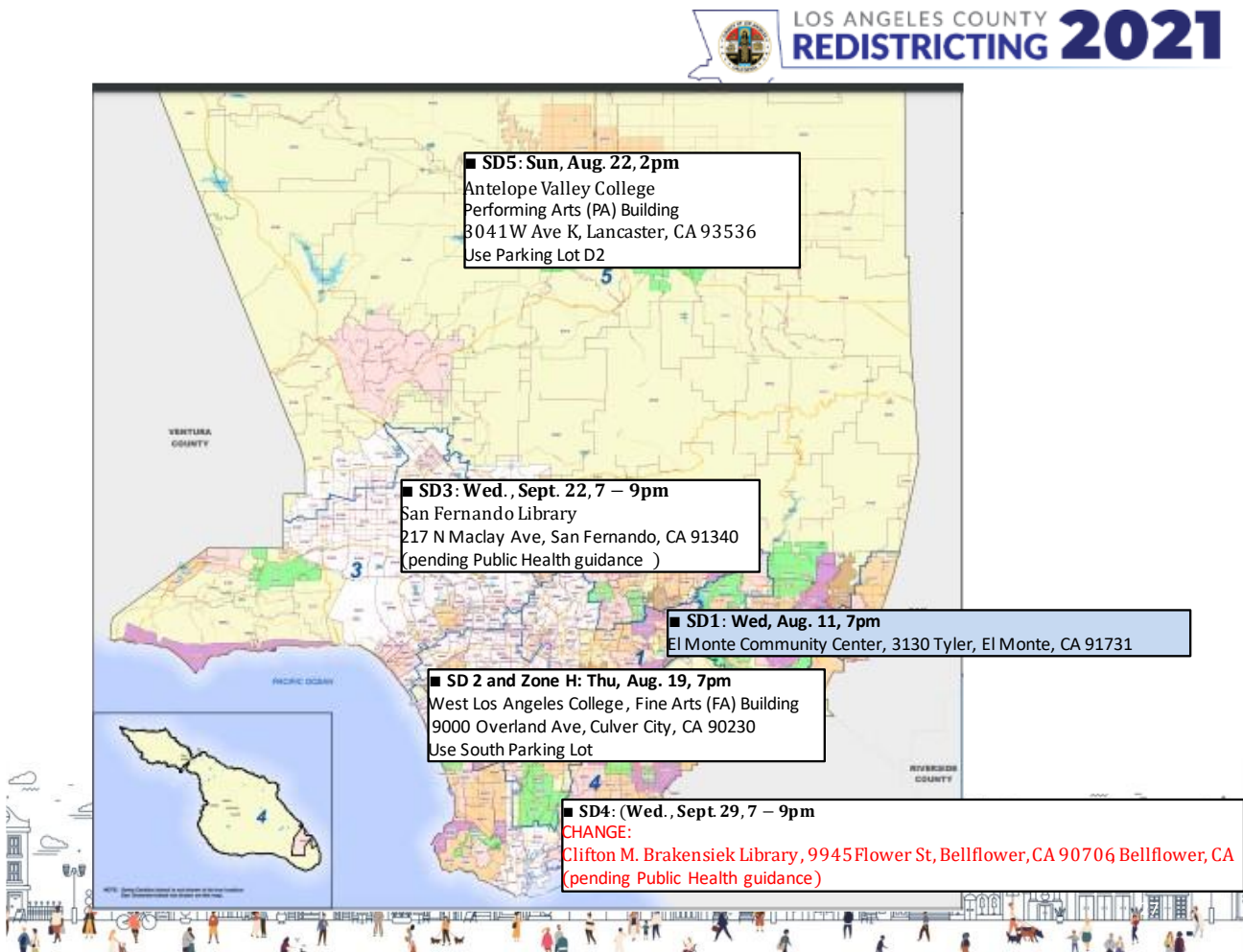
- October last week – Commission draws its map options to be posted for 7 days
- November – at least 2 public hearings 30 days apart
- December 15 – final maps
