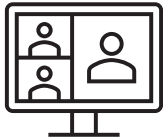

## ***5c. Consider Adopting Resolution Authorizing the Continuation of Hybrid and Fully Teleconferenced Meetings of the Commission for a 30-Day Period– Co-Chair Carolyn Williams and Co-Chair Daniel Mayeda***

**Background:** Recently passed legislation allows legislative bodies to continue to conduct teleconference meetings after September 30 if certain criteria are met and findings made. The LA County CRC adopted the formal Resolution No. 1 on September 29, 2021, to conduct its meetings virtually within the following 30 days. Resolution No. 1 expires on October 29, 2021.

The LA County CRC needs to re-adopt such findings at least every 30 days to enable the resolution to continue in effect because of health and safety issues.

Such extension of Resolution No. 1 would permit the LA County CRC to conduct its public hearings virtually in November (through November 28, 2021), as well as meetings within the following 30 days.
