Motion to Remove Map C-1

Suggested Approach to Narrowing Map Options Further

Co-Chair Dan Mayeda pointed out similarities among:

- Map Option A-1, which has modifications (“children”) with Maps E, F, 051, 052, 055, 056
- Map Option B-1, which has modifications (“children”) with Maps 042, 043, 045, 048, 049, 050, 054, 058

He used Map 050 as an example of how tweaks could be made to the map to reflect improvements in Map Option A-1.

Suggested “Tweaks” to Map Option F

The Commissioners reviewed Map Option F (itself a modification of Map Option A-1) and made some “tweaks,” based on public input, communities of interest groupings, and similar observations. They discussed how La Verne, San Dimas, Glendora, and Walnut dipped down into SD 1 and noted that it was justifiable because of a shared interest among the clustering of the foothill communities in the San Gabriel Valley.

Motion to Remove Maps A-1 and E

A motion was made and seconded to remove Maps A-1 and E from consideration as map options. Map F was the suggested base map to build on for further modifications of Map A-1. Commissioner Saira Soto strongly expressed the desire to retain Map A-1 as an option. There was no further Commissioner discussion. The motion passed.
