## Input on Map Modifications (Updated November 12, 2021)

#### *Map A or Map A-1*

- Connect Catalina with San Pedro or Long Beach as part of SD 4 – Done
- Do not divide Stonehurst Ave. residential street; combine western boundary for rural area, including landfills along Glenoaks and Sheldon and the Big Tujunga Wash and Hansen Dam Recreation Area with SD 5.
- Do not put SFV with Marina del Rey; goes too far south into Marina del Rey for SFV
- Include communities in western and northwestern SFV
- Include Lynwood with other SELA communities
- Include Porter Ranch in the SFV
- Keep communities in the western and northwestern SFV together
- Keep Glendale, Burbank, and Pasadena together
- Keep Long Beach together
- Keep SFV communities together: Chatsworth Lake Manor/Chatsworth/Porter Ranch/Twin Lakes/Granada Hills – closer to SCV or SD 5, not SFV

- Not connect Pomona with Torrance
- Questions about as LAX part of SD 2 or SD 3
- Questions about split cities
- Questions if Pomona should be part of SGV in SD 1
- Questions if SGV is kept whole
- Questions if Torrance should be part of SD 4
- Separate SFV low-income communities from wealthy coastal communities to avoid diluting their power

- Lake Manor, as extensions of the Tri-Cities communities (Burbank/Glendale/Pasadena) – all in SD 5
- Make Sunland/Tujunga/Kagel Canyon/Shadow Hills communities, along with the unincorporated areas of Twin Lakes and Lake Manor
- Move Beverly Hills + the west side south of Mulholland to SD 4 to empower NE Valley residents in new SD 3
- Move boundary south to National Boulevard for SD 3 to avoid splitting the Westside NC between two SDs; group with communities to the north in Westwood and the general UCLA community

- Keep Sherman Oaks, including POSO (Part of Sherman Oaks), together in SD 3; POSO is bounded by Oxnard Street (north), Hazeltine Avenue (east), Burbank Boulevard (south), and the 405 Freeway (west). – Done
- Keep Tri-cities of Burbank-Glendale-Pasadena together; separates Burbank from Glendale-Pasadena (Armenian-American community)
- Question dividing Long Beach
- Question of LAX placement

### **Map D or Map D-1**

- Combine City of Paramount with City of Lakewood
- Do not put Eagle Rock in SD 5; has nothing in common with the North County; Eagle Rock is urban, not rural
- Keep Foothill Communities Foothill Communities together; add Azusa, Covina, Duarte, and Claremont
- Keep SFV communities together: Chatsworth Lake Manor/Chatsworth/Porter Ranch/Twin Lakes/Granada Hills – closer to SCV or SD 5, not SFV
- Keep Sherman Oaks, including POSO (Part of Sherman Oaks), together in SD 3; POSO is bounded by Oxnard Street (north), Hazeltine Avenue (east), Burbank Boulevard (south), and the 405 Freeway (west).
- Keep the entire SFV in one SD, including the communities of Porter Ranch, Sylmar, and Granada Hills

- [Move Catalina to SD 4 – Done](#)
- Not place an African American community and a Latino majority district

### **General**

- Do not split up Encino
- Do not split Watts (LA) since it's a minority (historically underrepresented) community
- Keep Downey and Bell Gardens compact
- Keep each of the non-LA cities together and not separated (examples: Bell, Maywood)
- Survey of 500 SFV residents to be in 1 SD

### **Other**

- AAPI & AMEMSA Redistricting Collaborative includes COIs in Chinatown, Little Tokyo, Koreatown, Historic Filipino Town, Thai Town, the San Gabriel Valley, Gardena, Torrance, Carson, and West Carson
- Check these maps to ensure all residences in Eagle Rock, north of Colorado Blvd and south of 134 freeway, are included; keep zip code 90041 in one SD. Stated that south of the 134 is Eagle Rock and north of the 134 is Glendale
- In the case of Hawthorne, Inglewood, and Lennox, the Tongan community has a rich history of immigration.
- Keep Bell, Bell Gardens, Commerce, Cudahy, Huntington Park, Lynwood, Maywood, South Gate, and Vernon together
- Keep Chinatown and Little Tokyo together
- Keep Lynwood, Cudahy, Commerce, Vernon, Huntington Park, Maywood, Bell, Bell Gardens and South Gate
- Keep SELA communities and Florence Firestone together
- Little Tokyo boundaries are Main Street in the west; Temple Street in the north; Vignes Street in the east to E. 1st Street, where Hewitt Street becomes the eastern border; and E. 3rd Street in the south between Main and San Pedro Streets, where E. 4th Street becomes the southern border to E. 4th Place
- Samoan Community in the Western Long Beach & Carson areas: Keep the City of Carson and parts of West Long Beach whole. The boundaries of the Samoan community in West Long Beach start at Anaheim St. and the 103 Hwy, moving east to Orange Ave. The boundaries continue north to the 91 Highway and West to the 710. It runs along the 710 to the 405, and includes the Westside neighborhood running along the train tracks back to the 103.
- The business corridor that runs north-south along Western Ave from Gardena to Torrance remains a hub of activity and is economically significant for many Asian American businesses from restaurants and medical offices to auto body shops and various import-export companies.
